**2025.134 Quickline**

*To receive a presentation from a representative of Quickline regarding the roll-out of fibre broadband in certain areas of the parish, followed by a brief Question & Answer session.*

Mark Furnass from Quickline gave a shortened presentation on the roll-out of fibre broadband to non-central areas of the parish by Quickline as part of Project Gigabit. The provisional "Live Date" is 31<sup>st</sup> December 2026, but this could change. Poles are proposed to the north east and south west of Millington with a further pole on Church Lane.
